The story about to hear got the attention of a nation. The remains of a little girl found dead inside a trash bag in Massachusetts. Well, for months, police just couldn't figure out who she was or how she died. Catharine?

It was the mystery that haunted police for nearly 3 months. Who was the little girl whose lifeless body washed ashore Deer Island **clutching a blanket and wrapped in a trash bag**. The answer came in a tip to **BPD's homicide unit**. "We hoped against hope that her death was not a crime. But the evidence carefully and professionally gathered by the men and women who worked on this investigation, suggest otherwise" A Fox 25 source says Bella's mother saw her boy friend Michael MaCarthy allegedly punching Bella in her room before her dead. Today, MaCarthy was charged with murder. Bella's mother Rachelle with **accessory to murder**.

Investigators say Rachelle Bond was involved with the handling of Bella's body. And a source tells Fox 25, MaCarthy and Bond allegedly kept Bella's body in a freeze for nearly a month, before they **disposed** of it. "We allege that MaCarthy caused Bella's death that he did so intentionally that he and Bond took specific steps to keep Bella's death a secret and to avoid prosecution" Today police **comb** to the Dorchester home MaCarthy and Bond shared, the very place where they said Bella should have been safe.

And although the case is now solved, investigators say their **burden of grief** for that little girl remains heavy. "It's a good day that we butt a name to this face but, it's a sad day that we lost a young child and we'll never be able to bring her back" **May justice be served**. That was WFXT's Catharine Brookem reporting . At least, 10 people are now offering to take Bella's remains for a proper burial including Boston's **archbishop cardinal** Shanna Marley. But no final decision has been made as of today.
